We establish a relationship of trust and integrity with all our suppliers, which is built upon mutually beneficial factors. Our supplier selection and on-boarding procedure includes due diligence of the supplier's reputation, respect for the law, compliance with health, safety and environmental standards, and references.

Existing policies and procedures were considered, and it was noted that these effectively control this risk of slavery through:

- Codes of Conduct for employees and suppliers/business associates which clearly oppose slavery, forced labour, and other forms of human rights abuses.
- Application of risk assessment to all suppliers where an identified risk of slavery occurs. This includes the
 - o requirement for suppliers to provide a declaration of their anti-slavery practices.
 - Visits by Directors of the company to mines and factories to inspect the prevention of slavery factors.
- Has communicated to all employees that any suspicions of slavery within our supply chain can be reported to the Director confidentially, without fear of reprisal from management or other members of the company.
- Has completed training for the Directors of the company to enable them to understand the risk associated with modern slavery practices. This training is recorded within our training register.

The company will continue to review the risk profile of our supply chain and apply a proportionate response, having regard to any potential reporting of issues and changes to operations, and/ or supply chain that may arise and affect the risk profile.

The company has received no reports of modern slavery breaches within its operations and supply chain during the reporting period.

This statement has been approved by the Company's Board of Directors on the 19th of September 2023 and signed on the same day.
